Subject: Request for issuing of Fresh Notification for LICE in respect SDE (TF).

Respected Sir,

We would like to draw your kind attention on the above cited subject. After the formation of BSNL, no Limited Internal Competitive Examination was conducted for SDE (TF) under 33% quota. Examination Notification was issued for conducting LICE for promotion to the grade of SDE (TF) vide GM (Rectt) BSNL Letter No. 15-1/2016-Rectt, Dated 02.01.2017. This Notification was inclusive of LICES for the promotion of SDE (Civil), SDE (Electrical) and SDE (TF) under 33% quota to be held on 05.03.2017.

However, vide GM (Rectt) BSNL Order No. 30-2/2015-Rectt dated 28.02.2017, the Exam scheduled to be conducted on 05.03.2017 has been postponed till further orders due to the Stay granted by Hon'ble CAT, Chandigarh. It is learnt that the case is filed by Civil Wing personnel. But due to that Stay, BSNL is unable to conduct LICE for other two streams viz., SDE (Elect) & SDE (TF).

It is reiterated that there is no Court case filed from Telecom Factory side. JTOs who are working as JTO (TF) since 1996 are unable to get promotion in the cadre of SDE (TF) due to non-conducting of LICE. In Telecom Factory, there is a Chemist who appointed on 01.04.1989 is unable to get any career progression due to non-conducting of LICE for SDE (TF). The candidate already spent about 30 years in the same Cadre, and will be attaining the retirement age within few years. In the present scenario, Chemists are not considered for the promotion of SDE (TF) through SCF quota


The vacancy details in the cadre of SDE (TF) in Telecom Factory are as under.


